## **Key activities**

The NSW Resources Regulator published the following:

- a <u>media release</u> and related <u>safety material for industry</u> detailing the start of a targeted awareness campaign with coal workers to address the risk of collision between heavy mining equipment
- an investigation release about a fatality at a quarry after worker was struck by a light vehicle
- an <u>investigation release</u> about a dangerous blasting incident at a hard rock quarry.
- a targeted intervention report spotlighting electrical safety at tier 1 quarries and a
- reasons for decision for cancelling Exploration Licence 8967 under the Mining Act 1992.

Three penalty notices totalling \$12,500 were issued under the Mining Act 1992:

- two were issued to Macquarie Marble Lime Pty Ltd for failure to comply with directions totalling \$10,000 and
- one was issued to Marble Aggregates Pty Ltd for \$2,500 for late payments.

13 May	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	A dozer operator and haul truck interaction resulting in the truck operator narrowly missing the dozer cab with the dove tail of the truck while reversing out of the area at the face. The truck operator assumed the dozer was clear without waiting for positive communication from the dozer operator.
19 May	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	A light vehicle took evasive action to avoid a collision with a haul truck at an intersection. The light vehicle was travelling on the main haul road approaching an intersection when the haul truck turned right, into the path of the light vehicle. The light vehicle driver failed to slow down in accordance with the vehicle hierarchy road rules.
20 May	Coal mines	N/A	A passenger in an underground personnel transporter required surgery following a serious arm injury. The passenger's arm caught against a piece of plant when the vehicle was driven into a cut-through.
21 May	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	Both sets of rear wheels on a dump truck dropped approximately one metre when the edge of the dump slumped while the operator was tipping a load.
24 May	Small mines – Metalliferous, Quarries and Other Gemstones	N/A	A contract fitter was fatally injured after struck by a light vehicle.
26 May	Coal mines	Surface vehicle interaction - Roads	An excavator collided with a dozer causing significant damage to the cabin. It was reported

		and Vehicle other operating areas	positive communications had been established to allow the dozer to enter the excavator's swing radius but that the excavator restarted its operation before the dozer was clear of the swing radius.
27 May	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	An excavator collided with a dozer that was working inside the swing radius of the excavator. The excavator bucket has hit the exhaust stack and blade lift cylinder at the front of the dozer. There were no injuries.
31 May	Coal mines	Ground or Strata Failure	A continuous miner driver was standing at the start of a breakaway where the roof had been bolted, but not meshed. A one square metre piece of bratt (coal tops) broke off from between the roof bolts and hit the driver. The worker sustained soft tissue injuries.
