

Key activities

The NSW Resources Regulator published the following investigation and safety bulletins:

- consolidated <u>report</u> on roads or other vehicle operating areas at small mines and quarries as part of a planned inspection program
- a fact sheet on stockpile stability at surface coal operations
- a fact sheet on structural collapse at underground and surface coal operations
- four weekly incident summaries highlighting eight dangerous incidents
- consolidated <u>report</u> on entanglement in coal mines for February June 2021 as part of a planned inspection program
