Dangerous incident IncNot0040997 Underground coal Ground or strata A roof fall in an underground coal mine resulted in two workers suffering spinal, chest and leg injuries. The ply fell from between roof bolts.

Dangerous incident IncNot0041024 Underground metals A worker was in the process of repositioning an elevated work platform (EWP) when the machine unexpectedly rolled forward approximately one metre. The movement occurred when the operator placed his foot on the dead man switch and before operating the hand controls. The movement stopped when the operator released the dead man foot switch.



Mechanical engineering control plans must set out the control measures for the unintended operation of plant. This must include function testing as part of the introduction of plant to site process and pre-use inspections by operators.

Mine operators should ensure:

- all pieces of hired equipment have a thorough mechanical and electrical inspection to assess the plant's operation
- thorough pre-work inspections are carried out by competent people
- hired equipment is maintained in accordance with a suitable maintenance strategy considering the original equipment manufacturer's recommendations and relevant Australian Standards. For EWPs this should include AS 1418.10 and AS 2550.10.
