Dangerous incident IncNot0042123 Open cut coal Roads or other vehicle operating areas	A grader operator collided with a stationery dump truck after the operator suffered a microsleep. Nobody was injured and the damage was minor.	Mine operators should review their fatigue policy and site compliance. Contractor work groups should be included in this review. Schedule 2 of the Work Health and Safety (Mines and Petroleum Sites) Regulation 2014 includes the requirement that a health control plan must address control measures for minimising the risk that a worker will be impaired by fatigue. Mine operators should include worker fatigue monitoring and response technology as a part of their fatigue risk analysis.

Mineral claim

A track-mounted drill rig toppled onto its side. The rig was set up to drill a shaft on an opal claim when the rig was slewed and fell onto the cab side. The operator of the drill left the scene to formulate a plan to recover the drill rig. The scene was not preserved.



Mineral claim operators and their contractors are reminded that they have an obligation to notify the NSW Resources Regulator of certain incidents that occur on mineral claims.

Resources Safety and Health Queensland
