# **Executive Summary**

#### Overview

This report provides a summary of the performance for the provision of title assessments and processing within the NSW Department of Planning, Industry and Environment's Division of Resources and Geoscience (the Division) for Quarter 2 2019 (1 April 2019 to 30 June 2019).

The Division's performance is reported against the Service Delivery Standards, which note target timeframes for the processing of applications under the *Mining Act 1992*. These are published by the Division at:

### Processing timeframes and operations

Timeframes for the calculation of service performance vary depending on the type of application. For mineral exploration licence applications and renewals that require approval of a delegated officer rather than the Minister, the processing time for service level reporting is complete when the applicant is notified of the proposed decision for the application. For exploration licence applications and renewals for coal, where the approval of the Minister is required prior to issuing a notice of proposed decision, the processing time for service level reporting, where applicable, is complete when a submission is signed by the Executive Director Resource Operations within the Division and sent to the Minister for consideration.

If an application is deficient, the applicant is notified and given ten business days to submit all required supporting information. Processing timeframes commence when a complete application, including all required supporting information, is received.

Exception management (stop-the-clock) protocols apply when circumstances beyond the control of the Division's process prevent the valid assessment of an application. More information on exception management can be found at:

### Quarter 2 2019

#### Performance overview




Figure 1 Q2 2019 service delivery standard performance

This following chart (Figure 1) details performance of proposed decisions, security deposit releases and subsidence management plan approvals, as measured against the Service Delivery Standards published by the Division for Quarter 2 2019 (Q2). During this quarter, **82** notifications of proposed decisions, security deposit releases and subsidence management plan approvals were issued. Of these, **76 per cent** met the target timeframe.

#### Breakdown of submission timeframes

The following chart (Figure 2) details the timeframe in which matters were submitted for the proposed decision/security releases/subsidence management plan approvals in Q2 2019.

Not all proposed decisions/security releases in Q2 2019 were submitted during that quarter. Of the total 82 proposed decisions/security releases in Q2 2019, 55 were submitted in 2019. The remaining 27 proposed decisions were submitted prior to 2019, with some as far back as 2015.

## Performance by submission timeframe

The following charts (Figure 3 and 4) categorise performance by timeframe (i.e. on whether the application was submitted in 2019 or prior).

Of the 82 proposed decisions/security releases/approvals in Q2 2019:

- 55 were submitted in 2019, with a **98 per cent** meeting the target timeframe.
- 27 were submitted prior to 2019, with **30 per cent** meeting the target timeframe.


This indicates a 2019 performance improvement.

### Applications received

For Q2 2019, there were 94 applications received, compared to 110 for the same period last year. On average, there were approximately 98 applications received per quarter during the period 1 April 2018 to 30 June 2019.
