Continuous Miner intersects gas drainage hole. General Body 1.8% CH4 at drill rigs.

- Ensure power is removed if not tripped Greater than 1.25% CH4.
- Notifiable Incident WHS(M&PS) Regs 2022 Section 190 (1)(c) Uncontrolled escape of gas.
- May also be Section 128 (5)(b) Greater than 2% CH4 general body.
- Follow the procedure for closing / bagging bore holes.
- Remove people from face.
- Take witness statements, do a sketch of how face was.
- Make place safe: Extend vent tubes to face, set up a venturi & monitor gas levels.
- Barricade the area until told scene is released.
- Record on Statutory Report & fill out an Incident Report.
- Was the borehole on the ATM & /or in the correctly predicted location?

- To entire workforce, including a re-enforcement of compliance
- Verbal & written handover to oncoming shift.
- Crew responsible to be asked why

Deputy in panel doing an extended driveage 240m with 2 x S/Cars.

- Most S/Car cables / cable reels will only take approx. 180m.
- Therefore you will need to "back spool".
- There should be a procedure for "back spooling".
- Procedure will include: surge point, Spotter, cleaning of surge point, where both S/Cars are to be anchored for each sequence.

Question 10 (total of 20 marks) Technical statements and standards

Examiners' comments:

Deputy in Longwall panel with "Contractors" building a goaf seal.

- a) Discussions & checks prior: Procedure signed by all, knowledge of Mine & the emergency escape, training in task, UG knowledge.
- b) Excessive dust: ensure loading is done as per procedure (correct position), ventilation is to the correct standard (brattice wing in place).
- c) Legal Limits Dust: WHS(M&PS) Regs 2023 Section 41 (b).

Considerations – as per the Briefing Session

- Know poorly answered written exam questions
- Being able to answer the question as a "Deputy" This is essential.
- An emergency question Call the "emergency", take control, account for workforce (including all contractors), follow your "emergency' training & talk "emergency talk (Primary Egress / Secondary Egress, CABA, rescuers, non-verbal communication), delegate, communicate with crew & CRO, preserve the scene, witness statements, photos, incident investigation, incident report, EAP, debrief.
- A Ventilation question De-gassing with brattice or an auxiliary fan. Recirculation (causes, how to identify & remedy), Water gauge & Barometric pressure.
- Know your Mine.
- Do pit visits to Mine's that have a type of mining or hazard that you're not familiar with. Know the role of the Deputy at that Mine.
