The NSW Resources Regulator's key activities during the quarter included:

- two enforceable undertakings totalling \$236,332 were accepted in response to non-compliance with the *Mining Act 1992*
- 3 penalty notices totalling \$6,000 were issued in response to non-compliance with the Mining Act 1992
- publication of 3 videos on the Regulator's YouTube channel highlighting a safety incident at Peak Gold Mine, fires on mobile plant and winder controls shaft safety
- release of the 2021-22 Annual Mine Safety Performance Report
- an investigation information release on an uncontrolled dozer travelling 230m down a ramp
- safety bulletins concerning ignition risks from rare earth magnets, and monitoring and reporting for escape breathing apparatus
- · safety alert on the unintended movement of haul trucks
- · fact sheet concerning structural collapse
- 10 small mines roadshow events held throughout the state.


















Mining Act non-compliance by category and response - response is enforceable undertaking





Mining Act rehabilitation completion actioned



Rehabilitation security deposit review

Our inspectors regularly assess the surface disturbance (or proposed disturbance) of a mine or exploration site to calculate the security deposit. This is known as the assessed deposit. Once the assessed deposit is determined, we advise the area within Mining, Exploration and Geoscience responsible for title administration who vary the condition of the title and seek the additional funds-or in the case of satisfactory rehabilitation, returns some or all of the security deposit.
