Key enforcement activities

On 1 April 2019, the NSW Resources Regulator began prosecution proceedings against Peak Gold Mines Pty Ltd over a work-place death at a mine near Cobar in April 2017. The NSW Resources Regulator will allege the contract worker, died after working in hot and inadequately ventilated conditions about 900 metres underground at the mine's workings and that Peak Gold Mines contravened the *Work Health and Safety Act 2011*. Further details are published on our website.

On 2 April 2019, <u>Abterra Australia Pty Ltd</u> was convicted and fined \$180,000 for failing to comply with a legal obligation to pay an environmental rehabilitation security deposit under section 378D of the *Mining Act 1992*. The Court found Abterra failed to pay almost \$1.8 million in rehabilitation security deposits, in accordance with the conditions attached to its mining authorisation.

On 14 April 2019 the NSW Resources Regulator accepted an enforceable undertaking from Namoi Valley Bricks Pty Ltd following an investigation that alleged the company mined clay/shale and structural clay from the Wilga Park Clay Mine, near Gunnedah without authorisation between 2 May 2007 and 15 August 2017. The undertaking required Namoi Valley Bricks to donate \$10,000 to the scholarship fund administered by the Gunnedah Shire Council, pay \$51,737 in royalties, \$1,000 in administrative levies, \$1,000 in rental fees and \$8,000 in investigation and monitoring costs. Safety incidents of note

The NSW Resources Regulator responded to an incident at an underground metalliferous mine in Cobar on the 13 April 2019 where a fire occurred on an agitator truck. At the time there were 19 workers underground who retreated to refuge chambers while the fire was brought under control. Investigation into the circumstances of the fire continues. Safety Alert – SA19-02

The NSW Resources Regulator's <u>weekly incident summary</u> references any recently published safety publications. The alerts section provides further details about any dangerous and serious safety incident notifications received in April 2019.

Communication highlights

On 10 April 2019, the NSW Resources Regulator hosted a <u>Tailings management workshop</u> in Dubbo with industry and other regulators facilitated by Professor David Williams with the focus on leading practice methodologies and current research regarding tailings storage facing management. The workshop attracted over 130 attendees and involved presentations and discussions on specific risks and knowledge gaps in tailings management to help develop targeted strategies to address these issues

On the 12 April 2019, the NSW Resources Regulator released an <u>investigation information release</u> into an incident on 21 March 2019, where workers were evacuated after gas level rise.

Work, health and safety activities

Safety incident notifications received

In April 2019, 144 incidents were notified to the NSW Resources Regulator by mining operations. This was down 38 from the 182 received in March 2019.

Of the 144 incidents notified in April 2019, there were 12 incidents where the NSW Resources Regulator deployed inspectors for further investigation. See the table below for further details.

FIGURE 1. SAFETY INCIDENT NOTIFICATIONS BY SECTOR - APRIL 2018 TO APRIL 2019





TABLE 1. DETAILS OF INCIDENTS WHERE INSPECTORS WERE DEPLOYED - APRIL 2019

Date notified	Mine type	Incident
1 Apr	Coal mines – Surface	A dozer was working with an excavator. The dozer slipped off the excavator bench and rolled onto its side. No one was injured.
6 Apr	Coal mines – Surface	A haul truck rolled on side. No one was injured but the operator was trapped in the cabin of the truck.
9 Apr	Coal mines – Surface	During a pit inspection, a highwall failure was identified in a non-active mining area at the base of weathering material.
11 Apr	Coal mines – Surface	A dozer was working on a bulk push task, when the operator noticed a fire in the engine bay. The operator activated the fire suppression and evacuated the dozer.
11 Apr	Large mines, Metalliferous and Quarries - Underground	A cantor light truck driving past a stationary jumbo rig in the main decline struck a drill steel in the jumbo drill rack.
13 Apr	Large mines, Metalliferous and Quarries - Underground	An agitator truck was taking shotcrete underground when the operator noticed smoke coming from the truck. The operator activated the fire suppression system.
15 Apr	Coal mines – Surface	After a break, a dozer operator noticed movement had occurred in the highwall with a large section that had failed along a dyke.
16 Apr	Coal mines - Underground	A loader operator suffered lacerations and a potential fracture to the upper right arm while operating a LHD.
25 Apr	Coal mines - Underground	Workers were remote mining when the shearer and armoured face conveyor tripped out due to a suspected coal burst.
29 Apr	Small mines, Metalliferous, quarries and other gemstones – Surface	A wedge within a working face slipped approximately one metre. No workers were in the mine when it occurred and the area is now barricaded off.
29 Apr	Coal Mines - Underground	The single occupant and driver of a PJB truck travelling on the main road contacted a 2.4m roof bolt. No injuries were reported.
30 Apr	Coal Mines - Underground	A control system fault occurred when a worker heard the seam level material gates operate. The operator investigated and found the western material gates had opened, leaving a fall risk into the shaft sump.

Safety assessments

In April 2019 there were a total of 143 safety assessments across all mining sectors, down 109 compared to the previous month. Of the 143 assessments, 68 occurred in the coal sector (or approximately 48%).

PROACTIVE AND REACTIVE SAFETY ASSESSMENTS

In April 2019, 59 out of the 143 (41%) of the assessments conducted by the NSW Resources Regulator were considered proactive in nature.

Proactive assessments include targeted assessments and planned inspections. Reactive assessments are conducted in response to notifications and requests, including incident notifications, targeted interventions, statutory notifications and enquiries.


FIGURE 3. ALL ASSESSMENT ACTIVITIES BY NATURE - APRIL 2018 TO APRIL 2019




Compliance activities

Safety notices issued

In April 2019, the NSW Resources Regulator issued 119 safety notices, a decrease of 60 compared to the previous month of 179.

Safety prohibition notices issued

In April 2019, the NSW Resources Regulator issued 24 prohibition notices under section 195 of the Work Health and Safety Act 2011.

In April 2019, the NSW Resources Regulator finalised a total of five enforcement actions under the *Mining Act 1992*. These included issuing three penalty notices, one enforceable undertaking and one prosecution, details below.


