### Key enforcement actions of note

A work health and safety enforceable undertaking submitted by Clarence Coal Pty Ltd in January 2020 has been rejected by the NSW Resources Regulator. The undertaking submitted for consideration proposed various obligations by Clarence Coal to deliver benefits to workers, industry and the community. It was submitted after an investigation into an incident at the mine on 4 July 2018, where two workers were seriously injured when material from a rib and cornice fell on them. The Regulator considered the undertaking and on 24 February 2020 rejected the proposal, being of the view the circumstances of the incident warranted strong specific and general deterrence. The NSW Resources Regulator cancelled Mining Lease 1259 (ML1259 Act 1973) on 24 February 2020 for contraventions of title conditions. The title holder contravened the conditions by not submitting a mining operations plan prior to its expiry and failing to employ at least two competent people and expend an amount of not less than \$35,000 per year on operations carried out in the course of prospecting or mining the lease. See Section 125(1)(c) decision to cancel ML 1259.

#### Safety incidents of note

#### **Ground or Strata Failure**

A continuous miner was buried when an intersection fell in during a breakaway that was being supported in accordance with the mine's support plans. The fall was about 9 metres x 5.4 metres x 2.5 metres. No injuries were reported.

**Recommendation:** Mines must have adequate trigger action response plans in place to effectively react to changing strata conditions. Workers must be trained to use these TARPs to ensure they are acted on appropriately. Workers should constantly monitor strata conditions to identify areas that pose risks. When strata conditions change or mining commences in new areas, the risk assessment and controls identified should be reviewed and the principal hazard management plan should be updated.

#### Work Environment – Slips, Trips and Falls

An operator was accessing a haul truck via the stairs when the handrail gave way and the operator fell sideways to the ground, from a height of between one to one-and-a-half metres. The operator suffered a broken wrist and broken leg. The Regulator has commenced an investigation into this incident.

**Recommendation:** Mines are reminded of the need to identify, assess, manage and rectify defects that affect the safety of plant or structures.

#### Escape or release of substance or thing / Escape of substance

A loader was feeding a hopper, as it reversed it hit a red gas cylinder that was buried upside down. The gas cylinder was one of several that were being used as bollards for a collision barrier for a building. The gas cylinder was punctured, causing a pressure release that propelled it into the air where it hit buildings, before landing on the ground.

**Recommendation:** In developing control measures to manage the risks of interaction between mobile plant and fixed structures, mines need to ensure that the control itself does not introduce a new level of risk. Under no circumstances should gas cylinders be used for anything other than their intended use.





6 February	Coal mines - underground	A burst of coal has occurred on a longwall face panel. There were no injuries.	
9 February	Coal mines - Surface	An operator sustained an injured hand requiring medical treatment while exiting a bogged dozer.	
12 February	Coal mines – Underground	During a weekly electrical function test on a winder a low speed brake pad dislodged from the braking calliper. While examining the fault it was identified that the brake unit had a brake pad missing, four of the five brake pad retaining bolts had fallen out and the fifth bolt had sheared off in place. Further investigation identified that the internal threads of the calliper block were worn, creating a loose bolt fit and allowing the bolts to unwind under operational load conditions.	
13 February	Coal mines - Underground	A Continuous Miner was buried when an intersection had fallen in during a breakaway. The fall was approximately 9m x 5.4m x 2.5m and standing support was installed. There were no injuries. The other Continuous Miner in the panel was stopped.	
15 February	Small mines – Metalliferous, Quarries and Other Gemstones	A loader hit a gas bottle that had been installed upside down in the ground to serve as a bollard. Its contents released and the cylinder was propelled into the air causing property damage. No-one was injured and the scene was preserved.	
18 February	Coal mines – Surface	An operator was accessing a CAT haul truck via its steps when the handrail gave way. The operator fell approximately one metre and suffered a broken wrist. All haul truck were stood down pending inspection.	

Date notified	Sector	Incident	
23 February	Large mines – Metalliferous and Quarries	A worker suffered a suspected heart attack outside the surface first aid room. CPR was performed on site and an ambulance transported worker to hospital.	
24 February	Large mines – Metalliferous and Quarries	A continuous miner operator's exposure monitoring device recorded a respirable quartz exceedance.	
26 February	Small mines – Metalliferous, Quarries and Other Gemstones	A truck operator was injured when his head became caught between the truck's tailgate and the truck body. The worker had been trying to identify what was preventing the tailgate from releasing and was struck by the swinging tailgate. The worker was able to free himself and was later transported to hospital.	
27 February	Large mines – Metalliferous and Quarries	A worker was offsiding a jumbo which was bolting the 4 level BD pillar incline. After the worker manually scaled the work area, he commenced installing retaining caps resin capsules when a 20 kg rock slid from beneath the mesh and contacted him on the back of the head. The worker briefly lost consciousness and was later transported to hospital. The worker was wearing a hard hat.

#### **Proactive and reactive safety assessments**

Proactive assessments include targeted assessments and planned inspections. Assessments conducted in response to incident notifications, targeted interventions, high risk activity notifications and action requests are reported as reactive assessments. In February 2020, just over 40% of all site and desktop safety assessments were proactive. Of the 105 site assessments conducted, almost 85% were proactive.





FIGURE 4. SAFETY SITE ASSESSMENT ACTIVITIES BY NATURE - FEBRUARY 2019 TO FEBRUARY 2020

FIGURE 5. SAFETY SITE TARGETED ASSESSMENTS - FEBRUARY 2019 TO FEBRUARY 2020








Safety mining competence activities include certificate of competence (mutual recognition). In February 2020, 19 practising certificates and three practising certificates for mutual recognition were granted.


FIGURE 7. COMPETENCE AND PRACTISING CERTIFICATES GRANTED - FEBRUARY 2019 TO FEBRUARY 2020


FIGURE 8. MINING AUTHORISATIONS GRANTED - FEBRUARY 2019 TO FEBRUARY 2020





#### FIGURE 11. SECURITY REVIEWS COMPLETED - FEBRUARY 2019 TO FEBRUARY 2020




## Safety legislation and Mining Act notified compliance concerns

The NSW Resources Regulator uses a variety of enforcement tools under work health and safety legislation and the *Mining Act 1992* to ensure compliance. The approach taken depends on the significance and impacts of the breach, the tools available under the legislation and the NSW Resource Regulator's <u>compliance and</u> <u>enforcement approach</u>.

#### Safety legislation non-compliance breaches

In February 2020, there were six sustained non-compliance breaches determined under the Work Health and Safety (Mines and Petroleum Sites) legislation which resulted in one official caution and five with no further action.

#### Mining Act non-compliance breaches by regulatory response


