#### Key enforcement actions

The NSW Resources Regulator, undertook no significant enforcement actions in January 2019. However, 126 safety notices were issued, (up 48 on the previous month) including 13 prohibition notices.

#### Safety incidents of note

On 18 January 2018, the NSW Resources Regulator responded to two incidents:

- a driver being temporarily trapped when a water cart had rolled over at <a href="Mt Arthur Coal Mine">Mt Arthur Coal Mine</a> in the Hunter Valley and
- a mine worker suffering a serious leg injury while working at <u>Tahmoor Colliery</u>.

Both incidents are subject to ongoing investigations.

The NSW Resources Regulator's <u>weekly incident summary</u> provides further details of the dangerous and serious incident notifications received in January 2019.

#### Communication highlights

On 17 January 2019, the NSW Resources Regulator published a <u>safety bulletin</u> on mines and preparing for fires.


The NSW Resources Regulator issued an <u>Investigation information release</u> in January 2019 about a dangerous shot firing incident that damaged a vehicle in 10 April 2018.

# **Safety activities**

#### Safety assessments

In January 2019, the NSW Resources Regulator conducted a total of 275 assessment activities across all mining sectors, up 113 compared to the previous month. Of the 275 assessments, 135 occurred in the coal sector.

#### Proactive and reactive safety assessments

In January 2019, 131 of the 275 assessments conducted by the NSW Resources Regulator were proactive, that is unrelated to an incident or complaint. Proactive assessments include both targeted assessments and planned inspections. Reactive assessments, also shown, includes assessments conducted in response to an incident notification, targeted intervention, high risk activities and action requests.

#### Targeted assessment programs

Under the proactive assessment program, the NSW Resources Regulator conducted one targeted assessment on a principal hazard which included site visit (intensive onsite assessment) in January 2019. As a result, six safety improvement notices were issued to the mining operation.


# **Safety notices**



# **Safety notifications**

#### Safety incident notifications

In January 2019, 150 incidents were notified to the NSW Resources Regulator, down 20 compared to the previous month. Compared to the same month in the previous year, the number of notices has decreased by 7.

#### Safety statutory notifications

In January 2019, the NSW Resources Regulator received two high risk activity notifications under the Work, Health and Safety (Mines and Petroleum Sites) Regulation 2014.


# Mining related compliance activities

#### Key enforcement actions under the Mining Act 1992

The NSW Resources Regulator employs a range of enforcement tools for ensuring mining operations comply with the *Mining Act 1992*. These include official cautions, penalty notices, enforceable undertaking and suspending/cancelling titles.

In January 2019, the NSW Resources Regulator did not finalise any enforcement actions, this is down eight on the previous month.
