# **Key Activities**

The NSW Resources Regulator published the following investigation and safety bulletins:

- an <u>investigation report</u> into a serious injury, unexpected movement of powered roof support at Ulan Underground mine in December 2019
- an investigation release about a worker struck by light vehicle at a quarry
- an <u>investigation release</u> about a worker seriously injured during transit in underground roadway
- an investigation release about a worker seriously injured by recoiling pipe
- an investigation release about a collision between an excavator and dozer
- a <u>safety bulletin</u> providing safety advice on crawler utility vehicle runaway after two recent notifications for lost motion control and rolled, uncontrolled, down a gradient.

#### Other publications included:

- Industry awareness resources addressing the risk of collisions involving heavy mining equipment
- Mine safety performance report 2019-2020 following collation and analysis of industry work health and safety reports, incident notifications and our compliance and enforcement data.

As part of the Work Health and Safety (WHS) enforceable undertaking accepted by the Resources Regulator in September 2019, Otraco International Pty Ltd has developed and <u>published a best practice</u> video training package.

The Regulator issued the following rehabilitation information releases to draw attention to the achievement of rehabilitation outcomes:

- Catherine Hill Bay coal preparation plant and coal bin rehabilitation achieves residential, recreational and open space land uses
- Rehabilitation of Western Emplacement Area at Ravensworth Operations.

Two Mining Act enforceable undertakings were accepted totalling \$160,316 under the Mining Act 1992:

Hi-Quality Waste Management Pty Ltd for alleged mine clay/shale and structural clay without an authorisation that is an offence under s.5 of the *Mining Act 1992*


One penalty notice issued for \$1,000 was issued to NBH Resources Pty Ltd for failure to pay rent and levy under s.292c *Mining Act 1992*.

4 June	Coal mines	No related principal mining hazard or principal control plan	A large rock has fallen 25 to 30 metres from a highwall onto the cab of a dozer doing clean-up on the floor below. The rock shattered on impact and dented the cab and dislodged a pane of glass. The operator was not injured.
7 June	Coal mines	No related principal mining hazard or principal control plan	A worker in the workshop was standing on a work platform positioning a lifting sling onto a radiator cowling which was to be lifted by a crane back onto a dump truck. While adjusting the sling the cowl has moved causing the worker to fall from the platform onto a nearby trolley. The worker has not sustained any apparent injury.
15 June	Coal mines	Ground or strata failure	Sudden roof fall, approximately 6m long, full width of drive (5.4 metres) by 2 metres high occurred in the main gate. A continuous miner was within 5 metres inbye of fall, with two fitters working on the miner at the time. Fitters noticed some flaking in the roof and immediately went outbye just prior to the fall of ground.
15 June	Coal mines	Ground or strata failure	Fall of coal roof. Miner was operating inbye at approximately 60 metres. Workers retreated past fallen material which was passable under supported roof.
16 June	Coal mines	Mechanical engineering control plan	While in the process of dumping a load of coal the truck operator smelled "electrical" smoke in the cabin. The "E" stop in the cab was activated and emergency was called. The operator was





			taken to hospital to be checked for smoke inhalation.
18 June	Coal mines	Mechanical engineering control plan	The operator of a Hitachi EH4500 truck parked on a dump (not fundamentally stable) and was unable to activate the primary access ladder to egress the truck. The operator exited to the ground via the emergency ladder and activated the "E" stop.
21 June	Large mines – Metalliferous and Quarries	No related principal mining hazard or principal control plan	A rigger has fallen 3m from a scaffolding ladder after ducking under the handrail. The rigger was taken to hospital.


#### **Proactive and reactive assessments**








# Rehabilitation security deposit review

Our inspectors regularly assess the surface disturbance (or proposed disturbance) of a mine or exploration site to calculate the security deposit. This is known as the assessed deposit. Once the assessed deposit is determined, we advise Mining, Exploration and Geoscience who vary the condition of the title and seek the additional funds - or in the case of satisfactory rehabilitation, returns some or all of the security deposit.




## Non-compliance breaches sustained by category

SAFETY NON-COMPLIANCE BREACHES SUSTAINED BY REGULATORY RESPONSE






