Key enforcement actions

We commenced <u>prosecution proceedings against Narrabri Coal Operations Pty Ltd</u> in the NSW Land and Environment Court for alleged breaches of the state's mining laws in August. The matter relates to Exploration Licence EL6243, which forms part of Whitehaven Coal's Narrabri operations located at Boggabri.

An <u>investigation report</u> and <u>incident animation video</u> was released following a dangerous blasting incident that occurred at Albury Quarry, Ettamogah in April 2018. During the routine overburden blast large pieces of debris and rock were launched into the air striking three light vehicles that remained in an exclusion zone at the quarry. The report describes the investigation we conducted into the cause and circumstances of the incident and provides the investigation findings and recommendations to industry.

Safety incidents of note



A worker was found unresponsive in a load haul dump machine on the main travel road at an underground coal mine. Attempts to revive the worker were unsuccessful. Read the Investigation Information Release.



A rigid haul truck rolled over the side of a haul road at an open cut industrial minerals mine, coming to rest on the edge of a steep drop. The operator was wearing a seatbelt and suffered a minor injury. Initial enquiries suggest that sunlight interfered with the driver's line of sight,

causing the worker to drive into the bunding that was not adequate to hold up the truck. The truck drove over a large rock in the bund wall and tipped over. Mine operators should ensure that bunds are designed, constructed and maintained to a standard that is suitable to protect workers from harm.

Principal hazard management plans for roads or other vehicle operating areas should consider factors that may affect operator visibility or ability to control a vehicle such as sunlight, fog, or dust obstructions that may affect lines of sight. This incident also highlights the importance of wearing a seatbelt while operating mobile plant.



A worker's arm became caught in the tail pulley on the main drive of a screening plant belt at an open cut construction materials mine. The worker removed a guard to view the belt tracking and attempted to remove the roc by hand. The machine was at idle when the

incident occurred. We recently published an <u>Investigation Information Release</u> about a similar incident. Mine operators are reminded of their duty to identify hazards and manage risks to health and safety associated with the operation, maintenance and cleaning of plant. Mine operators and workers must ensure that when guarding around plant is removed for maintenance or cleaning purposes, all energy sources are isolated.



5 August	Large mines Metalliferous and quarries Surface	Dust hygiene monitoring resulting in the detection of two incidents of results exceeding 0.05mg/m³ respirable silica per cubic metre.
6 August	Small mines Metalliferous, Quarries and Other Gemstones	A rigid haul truck rolled over the side of a haul road, coming to rest on the edge of a steep drop. The operator was wearing a seatbelt and suffered a minor injury.
10 August	Coal mine Surface	A light vehicle turned in front of a haul truck at an intersection, narrowly avoiding a collision.




DATE NOTIFIED	SECTOR	INCIDENT
12 August	Coal mine Underground	Two fitters were at pit bottom servicing and inspecting an SMV as the operator of a Brumby attempted to reverse past the SMV, striking one of the fitter's left ankle and foot with the rear wheel of the Brumby.
13 August	Large mines Metalliferous and quarries Surface	An electrician was removing an insulator from a disconnected 22kV trailing cable. When the worker tried to remove the second insulator, their hand came in contact with one of the phase pins and suffered an electric shock. When the three-phase pins were tested, two read zero voltage while the third gave a reading of 108VDC. Subsequent testing returned readings of zero voltage on all three pins.
18 August	Large mines Metalliferous and quarries Underground	During shaft-lining operations, a winch cable snapped, resulting in a shotcrete hose-reeler moving about two metres and hitting the back of the shaft-lining rig. Up to 700 kilograms was suspended from the shaft-lining rig at the time. The lining rig weighed about 12 tonnes and was on the ground near the shaft opening. The cable reeler weighed about two tonnes and was behind the lining rig.
21 August	Coal mine Underground	A worker was found unresponsive in a load haul dump machine (LHD) on the main travel road at an underground coal mine. Attempts to revive the worker were unsuccessful. The LHD was running at the time the worker was found.
25 August	Coal mine Underground	A worker was hit on the leg while helping to remove a power pack from a longhole drill. The work group entered the area to remove the power pack, which was on a trailer. The regular access road was blocked, which led to the LHD approaching from the opposite direction. The trailer needed to be rotated 180 degrees in the roadway to hook up the trailer. During the rotation of the trailer, an operator entered the no-go area and was hit on the leg.
26 August	Coal mine Surface	A 30-tonne excavator conducting rehabilitation work was being walked backwards when one track rode up onto a rock pile, causing the excavator to overturn. The operator suffered a bump on the head.
28 August	Small mines Metalliferous, Quarries and Other Gemstones	A worker's arm became caught in the tail pulley on the main drive of a screening plant belt. The worker removed a guard to view the belt tracking and put hand in to remove a rock. The machine was at idle when the incident occurred.
31 August	Coal mine Surface	A 12V light system was in close proximity to grinding and air arc gouging on the tub of a dragline. The 12V power supply was wrapped in heat blanket to protect it and a welding screen was in place between it and the work. The 12V lighting breakout box and light cabling caught alight. Workers in close proximity extinguished the flames.

Proactive and reactive safety assessments

Proactive assessments include targeted assessments and planned inspections. Assessments conducted in response to incident notifications, targeted interventions, high risk activity notifications and action requests are reported as reactive assessments.

In August 2020, 69% of all site and desktop safety assessments were proactive. Of the 266 site assessments conducted, 89% were proactive.





FIGURE 4. SAFETY SITE ASSESSMENTS COMMENCED BY NATURE – AUGUST 2019 TO AUGUST 2020

FIGURE 5. TARGETED SAFETY SITE ASSESSMENTS COMMENCED – AUGUST 2019 TO AUGUST 2020







Safety mining authorisations include licence applications to carry out prescribed high-level activities, plant item registrations, design registrations and exemptions. During August, 31 item registrations, 11 licences, three design registrations and two exemptions were granted.



Reactive site assessments include assessments conducted in response to lodgement of mining operation plans, annual reports, security reviews, applications to conduct exploration activities, title dealings and action requests.





FIGURE 11. MINING ACT SITE ASSESSMENTS COMMENCED BY NATURE – AUGUST 2019 TO AUGUST 2020




FIGURE 12. MINING ACT STATUTORY NOTICES ISSUED BY NOTICE TYPE - AUGUST 2019 TO AUGUST 2020



Mining Act request for service

In August 2020, we actioned 297 requests for service. This included 250 requests from titleholders, 38 from Mining, Exploration and Geoscience concerning the administration of mining authorisations and nine requests from either the NSW Department of Planning or a local consent authority relating to development assessment applications under the *NSW Environmental Planning and Assessment Act* 1979.


FIGURE 13. REQUESTS FOR SERVICE ACTIONED BY SOURCE - AUGUST 2019 TO AUGUST 2020




Rehabilitation security deposit reviews

Our inspectors regularly assess the surface disturbance (or proposed disturbance) of a mine or exploration site to calculate the security deposit. This is known as the assessed deposit. Once the assessed deposit is determined, we advise the Mining, Exploration and Geoscience (part of Regional NSW) who vary the condition of the title to seek additional funds or, in the case of satisfactory rehabilitation, returns some or all of the security deposit.

In August 2020, we assessed nine exploration and five mining titles security deposits held for rehabilitation.





FIGURE 17. SAFETY NON-COMPLIANCE BREACHES SUSTAINED BY REGULATORY RESPONSE - AUGUST 2019 TO AUGUST 2020






FIGURE 18. MINING ACT 1992 NON-COMPLIANCE BREACHES SUSTAINED BY CATEGORY AUGUST 2019 TO AUGUST 2020
