Key enforcement actions

On 16 November 2020, the Resources Regulator commenced an <u>investigation</u> into illegal mining on a property at Sapphire, near Inverell which resulted in two prohibition notices issued under section 240A of the *Mining Act 1992* to immediately cease illegal mining. The site will be monitored to ensure compliance with the notices and the mining laws. Illegal mining can cause significant harm to the environment and damage sensitive ecosystems. Further compliance outcomes are being considered.

In November 2020, the NSW Resource Regulator partnered with the National Parks and Wildlife Service to <u>target illegal fossicking in the Torrington State Conversation Area</u>. Signs have been installed in the conservation area encouraging reporting of illegal fossicking, and drone technology will be used to detect the practice being carried out.

Safety incidents of note



At an open cut industrial minerals mine, a worker's head was trapped under a cab after it lowered onto the worker while maintenance was being conducted on the loader. An investigation is underway.



A dozer operator at an underground coal mine was pushing coal on a stockpile over a bridge coal valve on the surface of an underground coal mine. The stockpile under the dozer collapsed and the dozer was left suspended over the exposed valve prevented from falling by

the dozer's blade. Initial enquiries suggest the operator did not follow procedure. Mine operators and workers must ensure that they follow relevant procedures when operating plant on stockpiles.



A worker received a head laceration and lost consciousness after being struck by a slack cable on a monorail system at an underground coal mine. An investigation is underway.

Education and engagement activities

November saw the launch of the Lightning Ridge Environmental Awareness Course made available online, on-demand, to allow attendees to learn at their own pace.

During November 2020, we engaged directly with almost 648 external NSW mining industry participants via seven industry forums, five small mines and quarries health and safety roadshows, two educational training sessions and one opal mine safety workshop which were conducted in-person and/or online.



4 Nov	Coal Mines	Ground or strata failure	Whilst tramming the continuous miner back out of a dyke intersection zone a piece of dyke material dislodged from the roof. The dyke material struck the timber jack and rolled back onto the continuous miners bolting platform striking the operator on the right hip.
4 Nov	Large mines – Metalliferous and Quarries	N/A	An operator was using a scaling bar to attempt to free up a jammed drill rig carousel after a drill steel had become stuck. While pushing on the bar the operator lost his

			grip. The bar sprung back and hit him in the lower jaw causing a severe laceration.
13 Nov	Small mines – Metalliferous, Quarries and other gemstones	Airborne dust or other airborne contaminants	Three workers with airborne dust exceedances from e sampling conducted in October 2020.
16 Nov	Coal mines	N/A	A worker sustained a head injury during a conveyor belt extension in an underground coal mine. Slack cable was being moved inbye on the primary monorail system (from transformer to DMU), outbye of the DMU monorail tow arm. The worker was found by other workers in a hunched over position and semi-conscious. It is suspected that he was hit in the back of the head, as he could not recall what had happened.
16 Nov	Coal mines	Abnormal movement of excavated / surface strata	A major slump occurred on a coal stockpile. The slump migrated to three coal train wagons that were being loaded by manned front-end loaders. Coal slurry also flowed through to the rail tracks of several other wagons. A manned front-end loader was close to the failed stockpile. No workers were on foot in the area at the time.
19 Nov	Coal mines	N/A	The tripper on a gantry conveyor inadvertently moved about 20 metres causing the front bogies to de-rail. There was an operator on the tripper at the head chute at the time. The operator was uninjured. The gantry conveyor belt wasn't tracking properly, and operators were attempting to realign the belt. Due to damage to a mile post limit supply cable, the belt was run with the mile marker disconnected at the switch. It appears that the belt was caught up and dragged the tripper along, rather than the tripper moving by itself.
23 Nov	Coal mines	Persons and / or object exposed to edge / drop-off	D9T was pushing coal on a stockpile when the operator inadvertently trammed over a bridged coal valve. The coal under the dozer collapsed so that the dozer was perched over the valve with its tracks suspended in midair. The blade of the dozer prevented the plant from completely falling into the exposed valve. The operator was trapped until a rescue crew could drag the dozer off the top of the valve.




24 Nov	Coal mines	N/A	An operator was using a heavy lift loader to move a loaded shearer transporter a short distance. When negotiating a slight decline, the shearer transporter jack-knifed and snapped the tow hitch on the heavy lift loader. Preliminary investigation suggests that speed was a factor, as well as lack of knowledge/experience in moving heavy machinery on a decline. The investigation will determine if there was a delay in the shearer transporter brakes engaging, following application of the brakes on the heavy lift loader, and if there was a requirement for a tow vehicle to assist braking.
25 Nov	Coal mines	N/A	A load haul dump vehicle (LHD) and PJB collided in an underground coal mine. Two PJBs were travelling in convoy passing the LHD that was in a cut through. The first PJB passed safely, but the LHD pulled out and collided with the second PJB. The bucket of the LHD contacted the frame of the windscreen of the PJB on the driver's side. Nobody was injured.
27 Nov	Coal mines	Ground or Strata Failure	Roof fall that extended above the bolted horizon. The fall was discovered by deputy during routine roadway inspections.
30 Nov	Small mines – Metalliferous, Quarries and other gemstones	Loss of control of lifted load or load lifting equipment	A worker's head was trapped under a cab after it lowered onto the worker while maintenance was being conducted on the loader.

FIGURE 2. SAFETY ASSESSMENTS COMMENCED BY SECTOR - NOVEMBER 2019 TO NOVEMBER 2020




Proactive and reactive safety assessments


Proactive assessments include targeted assessments and planned inspections. Assessments conducted in response to incident notifications, targeted interventions, high risk activity notifications and action requests are reported as reactive assessments.

In November 2020, 49% of all site and desktop safety assessments were proactive. Of the 171 site assessments conducted, 84% were proactive.



Safety notices issued

In November 2020, we issued 146 statutory notices under the *Work Health and Safety Act 2011* which were 80 improvement notices, 56 notice of concerns, nine prohibition notices and one non-disturbance notice.

FIGURE 6. SAFETY NOTICES ISSUED BY NOTICE TYPE - NOVEMBER 2019 TO NOVEMBER 2020







FIGURE 7. COMPETENCE AND PRACTISING CERTIFICATES GRANTED - NOVEMBER 2019 TO NOVEMBER 2020



Safety mining authorisation activities

Safety mining authorisations include licence applications to carry out prescribed high-level activities, plant item registrations, design registrations and exemptions. During November, 84 item registrations, seven design registrations, 12 licences and three exemptions were granted.


FIGURE 8. EXEMPTIONS, LICENCE, DESIGN & ITEM REGISTRATIONS GRANTED – NOVEMBER 2019 TO NOVEMBER 2020







FIGURE 12. MINING ACT SITE ASSESSMENTS COMMENCED BY NATURE - NOVEMBER 2019 TO NOVEMBER 2020





Mining Act requests for service

In November 2020, we actioned 253 requests for service. This included 214 requests from titleholders, 29 from Mining, Exploration and Geoscience concerning the administration of mining authorisations and 10 requests from either the NSW Department of Planning or a local consent authority relating to development assessment applications under the *NSW Environmental Planning and Assessment Act* 1979.


FIGURE 14. MINING ACT REQUESTS FOR SERVICE ACTIONED BY SOURCE – NOVEMBER 2019 TO NOVEMBER 2020



Mining Act rehabilitation activities

In November 2020, we actioned three exploration, one mining rehabilitation completions and seven title relinquishments.




Rehabilitation security deposit review

Our inspectors regularly assess the surface disturbance (or proposed disturbance) of a mine or exploration site to calculate the security deposit. This is known as the assessed deposit. Once the assessed deposit is determined, we advise the Mining, Exploration and Geoscience (part of Regional NSW), who vary the condition of the title and seek the additional funds - or in the case of satisfactory rehabilitation, returns some or all of the security deposit.

In November 2020, we assessed 16 exploration and four mining title security deposits held for rehabilitation. We also assessed one request for review by Minister.





FIGURE 18. SAFETY NON-COMPLIANCE BREACHES SUSTAINED BY REGULATORY RESPONSE - NOVEMBER 2019 TO NOVEMBER 2020




FIGURE 19. MINING ACT 1992 NON-COMPLIANCE BREACHES SUSTAINED BY CATEGORY NOVEMBER 2019 TO NOVEMBER 2020
